The following terms and conditions apply to the Refer A Friend Campaign for Fletcher's Slip which will take place between 15th June 2026 and 31st May 2027. (Campaign Period).

1. Definitions: In this document:

| Gift Card | means a pre-paid Visa Gift Card for the value of \$2,000. |
| Campaign Period | means the period between 15th June 2026 to the 31st May 2027. |
| Introducer | means a person (existing resident or purchaser) who has purchased a lot from the Promoter at an Eligible Estate and who is not an external sales agent, builder representative or financial planner. |
| Introduction Form | means the Refer a Friend Introduction Form. |
| Promoter | means Cedar Woods Properties Limited (ABN 47 009 259 081). |
| Referred Friend | means the referred person (new purchaser) referred by the Introducer who enters into a contract for sale with the Promoter to purchase a townhouse or land at Fletcher's Slip. |
| Eligible Estate(s) | means the following estates: Fletcher's Slip. |

SECTION A: QUALIFYING FOR THE CAMPAIGN

- An Introducer is a person who has entered into a contract for sale of land with the Promoter in an Eligible Estate.
- A Referred Friend is a person who has not previously enquired about Fletcher's Slip.
- The Referred Friend cannot already be a resident or existing property owner within the Eligible Estate.
- Introductions by an Introducer of a Referred Person may be made by completing and signing a Refer A Friend Introduction Form (Introduction Form) and submitting the Introduction Form via email to the relevant estate email address (listed below) or delivering it to the Promoter's Sales Office.

 - if settlement under the contract occurs.

- The introducer will receive an email with instructions on how to verify their mobile number in order to activate the digital gift card. Once the mobile is verified the introducer will receive their digital gift card via text within 21 days.

SECTION C: GENERAL TERMS

- Cedar Woods reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the campaign at any time without notice.
- Cedar Woods reserves the right to verify the validity of each Introduction Form and to refuse to accept any Introduction Form that contains inappropriate material or those that were submitted in an inappropriate manner, which may include, but is not limited to actions that breach any relevant laws.
